

SPANISH BROADCASTING SYSTEM- Standard Call In To Win Rules

Official Rules and Regulation

1. No purchase necessary.

2. WHO MAY PARTICIPATE:

Any listener, age 18 years or older unless indicated by the individual contest.

3. ELIGIBILITY

A. Employees of Radio Station WCMQ-FM; WXDJ-FM, WRAZ-FM, and WRMA-FM (each a “Station”), Spanish Broadcasting System, Inc., its affiliates and their public relations agencies, participating sponsors and family members (family is defined as spouse, parents, children, sibling, aunts, uncles, cousins and grandparents) are ineligible.

B. One prize per winner and his/her immediate family (family is defined as spouse, parents, children, sibling, aunts, uncles, cousins and grandparents) and or/household (household is defined as anyone living at the same address) is allowed within a forty-five (45) day period.

C. Any individual who wins \$600 or more in one calendar year from Station will be required to present a valid social security card or individual taxpayer identification number (“ITIN”) and proper government issued photo ID which contains the individual’s current address. Failure to present a valid social security card or ITIN may result in a disqualification of the winner, in which case the prize shall be forfeited.

D. **If the winner selected is later determined by the station to be ineligible, no prize will be awarded in that specific contest.**

4. NATURE OF CONTEST:

Listeners will be asked to call in on the listener lines to Station and be the correct numbered caller. The on-air personality will determine the numbered call sought. The contestant may be asked to participate in an additional manner, such as, but not limited to, singing the Station jingle or answering a trivia question, to win. Station shall have no responsibility for any claimed failure or inability to participate, win and/or claim any prize based on allegations of telephone problems.

5. PRIZES:

As indicated on-air by the announcer; prizes will vary per contest.

6. RETAIL VALUE:

The approximate retail value of the Prize varies up to \$1,000.

7. RESPONSIBILITY:

Station, Spanish Broadcasting System and participating sponsors will not be responsible for any claims, liabilities, losses, repairs, damage or injuries arising out of or in conjunction with the services, merchandise or other benefits obtained by the winner or this contest.

8. REDEEMING OF PRIZE:
